

RESOLUTION 19-R-A-42 to annex approximately 297.5 acres along Joe B. Jackson Parkway and Elam Road, and to incorporate the same within the corporate boundaries of the City of Murfreesboro, Tennessee, Betty and Elizabeth Dempsey, applicants. [2019-511]

WHEREAS, the Owner(s) of the territory identified on the attached map as the "Area Annexed" have either petitioned for annexation or given written consent to the annexation of such territory; and

WHEREAS, a Plan of Services for such territory was adopted by **Resolution 19-R-PS-42** on December 5, 2019; and

WHEREAS, the Planning Commission held a public hearing on the proposed annexation of such territory on October 2, 2019 and recommended approval of the annexation; and

WHEREAS, the annexation of such territory is deemed beneficial for the welfare of the City of Murfreesboro as a whole.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MURFREESBORO, TENNESSEE, AS FOLLOWS:



SECTION 2. That this Resolution shall take effect upon the effective date of the Zoning Ordinance with respect to the annexed territory, **Ordinance 19-OZ-42**, the public welfare and the welfare of the City requiring it.




